NOTE:

- 1) Candidates selected will be eligible for DA, Perks and other allowances as applicable in MAHA-Metro.
- 2) The number of vacancies mentioned above are provisional and may increase or decrease or may even become nil in total or in specific communities at a later stage, depending upon the actual requirement of MAHA- Metro.
- 3) Age Limits and Experience will be reckoned as on the Closing Date of the application.

SELECTION PROCESS: The screening methodology/ selection process will comprise of Personal Interview followed by Document Verification and Medical Examination as per the category prescribed for the post. The selection process would judge different facets of knowledge, skills, experience, expertise, aptitude, and physical fitness. The candidates will be shortlisted for an interview, based on their eligibility/ qualifications/ experience in the relevant field. If sufficient candidates are not available for the advertised post, the candidates with lesser service length/ higher age/ lesser experience/ relaxed qualification etc. may be considered for short-listing in the same post/ appropriate lower grade post and their empanelment will be based on the performance during the interview.

AGE RELAXATION: Age Relaxation (If any) for SC/ ST/ OBC (NCL) will be as per the norms of Government, wherever applicable.

For the serving non-executive MAHA-Metro employees ***working on Regular or Contract basis in IDA Pay Scale***, who are applying for the post up to Assistant Manager level, the relaxation in upper age limits will be up to 40 years for Unreserved, SC/ ST, OBC candidates, if the post is earmarked for UR. However, if the post is reserved for SC/ ST or OBC, the age relaxation will be 45 years for SC/ ST candidates and 43 years for OBC candidates.

These age relaxations will be applicable provided they have put in a minimum of 3 years' continuous service (LWP/EXL) in MAHA-Metro.

MEDICAL EXAMINATION: The selected candidates will have to undergo medical fitness examination in MAHA-Metro's nominated hospital as per the medical category prescribed for the respective post. Candidates who fail in the prescribed medical test will not be given any alternative employment. HOW TO APPLY AND GENERAL CONDITIONS:

- a. The complete filled in application form along-with the requisite certificates/ documents and two copies of recent passport size photos should reach this office at the address given herein latest by 18.09.2026.
- b. Candidates are required to read the entire recruitment notification and its instructions carefully to make themselves familiar with the eligibility, age criteria, other conditions, norms, etc. for the desired post and all the related information, instructions of this recruitment process.
- c. The SC/ ST candidates are requested to submit caste certificate in the prescribed format issued by competent authority. (Format is available on the official website of MAHA-Metro).
- d. The OBC candidates should ensure that they belong to the OBC-Non Creamy Layer (NCL) category while applying for the posts against this advertisement. Such candidates should submit a valid OBC (NCL) certificate in the prescribed format issued by the Competent Authority. (Format is available on the official website of MAHA-Metro).
- e. Processing charges/ Application fees: SC, ST and Women candidates are required to pay a non-refundable amount of Rs. 100/- as processing charges. However, UR & OBC (including Ex-servicemen) candidates are required to pay non-refundable fees of Rs. 400/-. The processing charges/ application fees can be paid in the form of Demand Draft in favour of 'Maharashtra Metro Rail Corporation Limited', payable at Nagpur or through online payment in MAHA-Metro's account by scanning the QR code attached through UPI App or BHIM App.

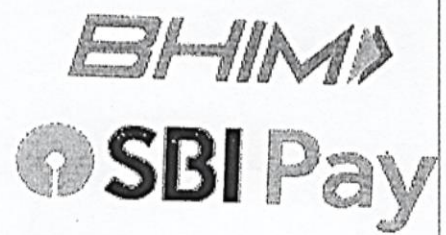
- f. If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his/ her application is false/ incorrect or the candidate has suppressed any relevant information or the candidate does not satisfy the eligibility criteria for the post(s), his/ her candidature will be rejected.
- g. Selected candidates will be required to sign a service/ surety bond in accordance with the Bond Policy of MAHA-Metro, to serve the Corporation for a minimum period of three years (exclusive of the period in which one remains on Leave without pay/ Extra ordinary leave (LWP/ EXL).
- h. There will be no guarantee for promotion/ advancement to the subsequent higher grade(s) within the organizational structure, and the individual/ incumbent appointed to the specified post has to fulfil their duties in that role for the duration of the contract.
- i. **Candidates who are eligible and wish to apply for more than one post will have to submit separate applications, along with the applicable application/ processing fee.**
- j. **Candidates once selected are liable to be posted at any place where MAHA- Metro project is in operation or is likely to be started.**
- k. - p. The candidates who qualify the selection process will be informed through registered E-mail ID.
- q. The selected candidates will be sent for medical examination as per medical standard mentioned on Maha Metro website.
- r. Maha Metro reserves the right to incorporate any subsequent changes/ modifications/ additions in the terms & conditions of recruitment under this advertisement as necessitated and applicable.
- s. Applications that are incomplete or improperly submitted or the applications received after due/ closing date will be rejected without further consideration.
- t. In the event of a shortfall in the number of candidates empaneled or other unforeseen circumstances, Maha Metro retains the right to engage candidates from the merit list or waitlist as necessary, based on merit and any applicable reservation criteria.

- u. No TA/ DA shall be paid for attending screening/ document verification/ medical examination/ joining duty on selection.
- v. While applying for the post, the applicant should ensure that he/ she fulfils the eligibility and other norms mentioned above on the specified dates and that the particulars furnished by him/ her are correct in all respects.
